

# Privacy Policy

myamana go (Telegram)

## 1. Introduction

---

Welcome to **myamana go** (“we,” “our,” or “us”). This Privacy Policy explains how we collect, use, and protect your personal information when you use our application, including when you choose to log in using Telegram Login.

## 2. Information We Collect via Telegram Login

---

When you log in to myamana go using Telegram, we receive a limited set of information from your Telegram account. Authentication may occur through the Telegram Mini App (in-app) or the Telegram Login Widget (browser). In both cases, we collect only the following:

**a. Name** (first\_name, last\_name)

We collect your first name and, where provided, your last name as set in your Telegram profile. This is stored against your myamana go account and used to identify you within the app.

**b. Telegram User ID** (id)

We collect your unique numeric Telegram user ID. This is used to link your Telegram account to your myamana go account and to verify your identity on subsequent logins.

**c. Username** (username)

Where available, we collect your Telegram username. This may be used for display purposes or account reference within the app.

The following data is transmitted during authentication but is used only for verification and is not stored:

**d. Profile Photo URL** (photo\_url — Login Widget only)

When authenticating via the browser Login Widget, your profile photo URL may be included in the authentication payload. It is used solely for cryptographic signature validation and is not retained.

**e. Authentication Date and Hash** (auth\_date, hash)

A timestamp and cryptographic signature are used to verify the authenticity and freshness of your login. These are discarded after validation and are not stored.

## 3. Information You Provide During Registration

---

After authenticating via Telegram, you will be asked to provide additional information to complete your registration. This may include your full name, date of birth, gender, country, phone number, and identity documents for verification (KYC) purposes. This information is entered by you directly and is not obtained from Telegram.

## 4. How We Use Your Information

---

We use the information collected through Telegram Login and during registration to:

- Create and manage your account on myamana go
- Personalise your in-app experience
- Send you service-related communications
- Comply with applicable laws and regulations
- Verify your identity as part of our Know Your Customer (KYC) obligations
- Provide customer support and respond to your inquiries

## 5. Data Sharing and Disclosure

---

We do not sell, rent, or trade your personal information to third parties. We may share your data only in the following circumstances:

- **Service Providers:** Trusted third-party vendors who assist us in operating the app, under strict confidentiality obligations
- **Legal Compliance:** When required by law, court order, or regulatory authority
- **Business Transfers:** In the event of a merger, acquisition, or sale of assets, your data may be transferred to the new entity

## 6. Data Retention

---

We retain your personal data for as long as your account is active or as necessary to provide our services. You may request deletion of your data at any time by contacting us (see Section 9).

## 7. Your Rights

---

Depending on your jurisdiction, you may have the right to:

- Access the personal data we hold about you
- Request correction of inaccurate data
- Request deletion of your personal data
- Withdraw consent to data processing at any time
- Disconnect your Telegram account at any time via your [Telegram Privacy Settings](#)

## 8. Data Security

---

We implement industry-standard technical and organisational measures to protect your personal information from unauthorised access, alteration, disclosure, or destruction.
