

Terms of Service

myamana go (Facebook Login)

Effective Date: 11 July 2026

1. Acceptance of Terms

By using myamana go and choosing to log in via Facebook Login, you agree to these Terms of Service (“Terms”) and our [Privacy Policy](#). If you do not agree, please do not use the Facebook Login feature or our app.

These Terms apply to your use of the myamana go application (“App”), operated by Huozhi Ltd (UK Company No. 10187997, HMRC MLR No. XBML00000187275), trading as **Amanacard Group**.

2. Facebook Login

myamana go uses Facebook Login to allow you to sign in quickly and securely. When you use Facebook Login, you authorise us to access certain information from your Facebook profile as described in our Privacy Policy, including your email address and public profile information (your name, profile picture, and Facebook user ID). You enter your date of birth directly in the App during registration; we do not request or receive it from Facebook.

You may revoke this access at any time via your Facebook App Settings at facebook.com/settings?tab=applications. Revoking access will not automatically delete data already collected; to request deletion, see Section 6 below.

3. Eligibility

You must be at least 18 years old, or the age of majority in your jurisdiction, to use this App. By using the App, you represent and warrant that you meet this requirement.

4. Your Account and Responsibilities

You are responsible for maintaining the confidentiality of your account and for all activity that occurs under it. You agree to notify us immediately at service@amanacard.com if you suspect any unauthorised use of your account. You agree not to use the App for any unlawful purpose or in any way that violates these Terms.

We collect and use your data only as described in our Privacy Policy. We do not sell, rent, or trade your personal information to third parties. Your data is used solely to provide, personalise, and improve your experience within myamana go.

We process your data in accordance with the [Meta Platform Terms](#) and all applicable data protection laws, including the UK GDPR.
